Invitation for Sealed quotation for Procurement of Fabricated Steel Parts for Short Span Trail Bridges(SSTB)

First Date of Publication:-2077/09/13

1. The government of Nepal(GON) has allocated funds availed from World Bank through Rural Access Improvement and Decentralization Project (RAIDP) to TRM for **Trail Bridge Program** and the TRM intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Short Span Trail Bridges (SSTB).Bid is open to all eligible Nepalese Bidders.
2. The TRM office, **Bongadobhan Baglung** invites sealed bids from registered fabricators for supply of fabricated steel parts for following Short Span Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years and enlisted by DOLI are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DOLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

5. Bidding documents may be Purchase from the office of Tamankhola Rural Municipality, Bongadobhan, Baglung by eligible bidders ,on Submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the flowing table below, until the office hour up to **2077/09/27** from the first date of Publication of this notice.
6. Bids must be submitted to the office of **Tamankhola Rural Municipality,Bongadobhan-Baglung**,on or before **12:00 hrs noon on 2077/09/28**.Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders representatives who choose to attend at **13:00 hrs on 2077/09/28** at the office of **Tamankhola Rural Municipality,Bongadobhan-Baglung**. Bids must be valid for a period **90 days** after bid opening and must be accompanied by bid security, amounting to **a minimum as listed below in the table**, which shall be **valid for 30 days** beyond the bid validity period.
