4. Sealed bids must be submitted to the office Tamankhola Rural Municipality, Bongadovan Baglung by hand on or before 12:00 PM on 2077/11/03. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders representatives who choose to attend at 2:00PM on 2077/11/03 at the office of Tamankhola Rural Municipality, Bongadovan Baglung Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs.25000.00 (in words twenty five thousand only) which shall be valid for 30 days beyond the validity period of the bid (i.e.2078/1/16).
